# Rules of the game "Euro 2020 Predictions"

# I. Organizer / Purpose

MIS Group, head office 85 rue Nationale, 59800 Lille, France, is organizing a "Euro 2020 Predictions" game during the official "Euro 2020" football championship from June 11 to July 11, 2021. The game is intended for members (panellists) of any website belonging to the MIS Group company.

## Apple or Google are in no way involved in these prizes.

### **II.** General Terms and Conditions of Participation – Registration Procedures

This game is exclusively reserved for natural persons aged 16 or over at participation deadline residing in France, Belgium, Luxembourg, Switzerland, the United Kingdom or Italy, not legally incapacitated, with access to the internet and having an account on one of the partner sites (pipeul.com; testerdesproduits.fr; reunionsdeconsommateurs.com; devenirclientmystere.com; avispanel.com; surveyfriends.co.uk; paidfocusgroup.co.uk; paidproducttesting.co.uk; panelopinion.com; testailprodotto.it; & paneleuropa.it).

The organizer, the organizer's employees and family members or any other person professionally connected to the game are excluded from taking part.

The game will run from June 1, 2021, to July 11, 2021, the date and time of French connection being taken as proof.

To take part in the game, the participant must predict the score(s) of the match(es) of their choice during the official "Euro 2020" competition. The tipsters will be ranked and updated after each match.

The points awarded to each participant will be as follows:

• 5 points if the participant predicted the correct result

or

• 2 points if the participant predicted the correct goal difference

or

• 1 point if the participant predicted the correct winner (including draws)

The score used is the one at the end of the match, including any extra time but excluding any penalty shoot outs at the end of extra time.

- For example, let's say the Belgium-Germany match ends with Belgium winning 3-1.
- Marie predicted Belgium 2 Germany 0. She got the wrong score but the right goal difference and so she wins 2 points.
- James predicted Belgium 0 Germany 2. He didn't get the right score, the right goal difference, or the right winner, so he wins 0 points.

- Jo predicted Belgium 3 Germany 1. He predicted the correct score and wins 5 points.
- Giorgio predicted Belgium 5 Germany 0. He didn't get the right score or the right goal difference, but he did pick the right winner, so he wins 1 point.

At the end of the event, the winners will be determined according to their ranking. The top 50 will receive a prize as listed below (Article III).

If several participants win the same number of points, there will be a draw to decide between them.

By taking part in this game, participants provide the organizer with personal data. They agree that the organizer may use their data and, for a period of 99 years following completion of the game, may claim no other compensation than that of taking part in the game.

Only one participation per person is allowed for the duration of the game. In the event of noncompliance with the rules (e.g. multiple entries), the organizer reserves the right to cancel a participant's entry.

Multiple entries from professional groups, consumer groups or third parties will not be accepted.

The organizer reserves the right to check the accuracy of the data provided by the participant. Any person who does not meet the conditions of participation will be excluded from the game and will not be allowed to win a prize under any circumstance.

The organizer reserves the right to exclude any participant who has provided a false identity or false address, who has tried to cheat or, more broadly, contravenes one or more the rules' provisions.

The organizer may not be held responsible for registrations either late, incomplete or lost whether due to technical or other reasons.

Participation in a form other than that provided for in these rules will not be accepted, and will thus be considered null and void and not give rise to any reimbursement of connection fees.

#### III. Presentation of the prizes and designation of the winner

The closing date of the game will be July 11, 2020, on completion of the Euro final.

The winners will be announced at the end of the game unless there is a tie in participant point number. In this case, a draw will be held on July 12, 2021, and the results announced that day.

Prizes will be awarded according to final ranking:

- 1st place: a cheque for €500 (or £500)
- 2nd place: a cheque for €300 (or £300)
- 3rd place: a cheque for €150 (or £150)
- 4th to 20th place: a €20 (or £20) gift certificate to be selected from the following list: Kadéos, Illicado, Tir Groupé, Amazon, Decathlon, Carrefour, Auchan, Leclerc or Playstation for France; Love2Shop or Amazon for the UK; and Amazon, Zalando, Decathlon, Ikea, Esselunga or Carrefour for Italy.
- 21st to 50th place: a €10 (or £10) gift certificate to be selected from the following list: Kadéos, Illicado, Tir Groupé, Amazon, Decathlon, Carrefour, Auchan, Leclerc or Playstation for France;

Love2Shop or Amazon for the UK; and Amazon, Zalando, Decathlon, Ikea, Esselunga or Carrefour for Italy.

The winners will be notified on the MIS GROUP panel sites and corresponding social network accounts, and will also be contacted by email.

No one may win more than the allocated prizes. Prizes may not be exchanged in any way whatsoever.

The components of the prize are not covered by any warranty and cannot be exchanged or returned.

If the winner is unable to use their prize for any reason whatsoever, they will lose all benefit thereof and the organizer may dispose of it at their own discretion without being held liable to the winner.

#### IV. General terms and conditions

Participation in the game implies the express and unreserved acceptance of these rules and all their stipulations, the rules of good conduct in force, as well as the current laws and regulations applicable to games in France.

Participants are prohibited from implementing or endeavouring to implement any means of participating that does not strictly comply with the principles of the game and these rules. The organizer reserves the right to disqualify any participant who impairs operation of the game or who violates the official rules.

The organizer reserves the right to prosecute any person who attempts to defraud or interfere with the proper conduct of this game, and to carry out any checks to ensure compliance with these rules, in particular removing any participant who has committed any abuse or attempted fraud.

It is agreed that the data contained in the organizer's information systems have evidentiary force in all disputes as to the participants' personal data, as well as information resulting from the processing of files relating to the game.

The present rules are available free of charge and on request from the organizer, MIS Group, or from the game's partner sites.

The winners agree to participate in any publicity accompanying or resulting from the game with no additional compensation. The winners hereby authorize the organizer to use, free of charge, the data provided in this game for a period of 99 years from date of game completion, whether on multimedia or in any public promotional event the organizer may relate to the game, without this providing any rights other than the prize won.

The sale, transfer or exchange of the prize is strictly prohibited. Any attempt to sell, transfer or exchange the prize will result in its withdrawal by the organizer and its cancellation.

In accordance with the law, the organizer shall not be liable for any loss or damage caused by factors relating to the game, the winner takes part in the game at their own risk and the organizer may not be held liable with respect to the prizes for any reason whatsoever. The organizer will not be held responsible for circumstances beyond its control once the prize has been awarded to the winner. The winner is subject to the same policies, terms and conditions of any third party involved in the conduct of this game. The terms and conditions applicable to the prize have been provided to the best of our ability.

The organizer reserves the right to extend, shorten, modify or cancel this game due to *force majeure* or events beyond its control. If, for any reason whatsoever, this game does not take place as planned, for example due to fraud, technical failure or any other reason beyond the control of the organizer, and jeopardising or affecting the management, security, fairness or proper conduct of the game, the organizer reserves the right to cancel, modify or suspend the game or terminate it immediately without the participants being able to invoke the organizer's responsibility for this.

In accordance with the law, the organizer will adjudicate any question of application and/or interpretation of these rules, as well as any question not established by them that may arise during the game. Any question as to the legal interpretation of these rules will be subject to French law. In the event of legal action, and following attempts to resolve any dispute amicably, French courts will have sole jurisdiction.

Participants may request access to their personal data and/or correct it if it is incorrect. To exercise these rights, participants may contact the organizer.
